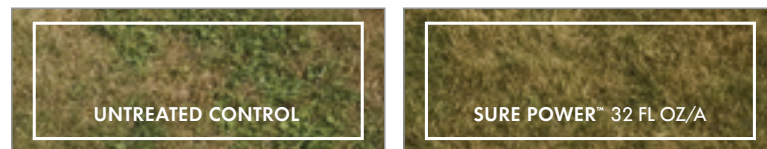

KEYS TO SUCCESS

1. Best used during a wide application window of July 4th to Labor Day when turfgrass cuticles are thicker.
2. DO NOT tank mix Sure Power with any other products including adjuvants, oils, wetting agents, fertilizers, surfactants or other active ingredients such as pre-emergence herbicides as turf damage may result.
3. Use caution when applying to ensure no spray solution or heavy dew collects on the tires of application equipment as accumulation on tires can lead to tracking.
4. Avoid applications during conditions of fog, high moisture, and wet foliage.
5. Avoid applications for a minimum of 14 days following frost or freezing air temperatures.

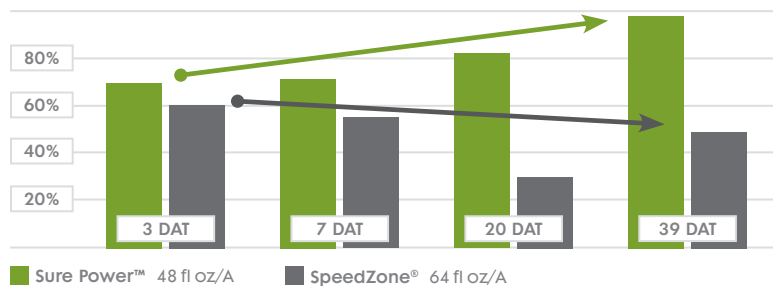
